#### A. Directors Report

Director Grannan informed that while the Board thought including the removal of tile in certain areas should be included into the flooring bids; she has come to the conclusion that it will be best to keep it separate from the bid. The Director informed that Chris Kyle has been running the inside crew and keeping our building and programs running smoothly and how fortunate we are to have staff members such as Chris that just step up and keep everything running. The PDRMA Health cost has risen 4.9% this year; due to some changes within the plan this will have a minimal affect on the district. One factor involved is the return of net position from PDRMA and that will be credited each month during 2024. Director Grannan also informed that she and Treasurer McDonnell have talked about the levy and bond issuance and she will be working on the budget and meeting with staff on the budget. Recreation Supervisor Kirstin will be attendance with the Director at the Community Expo at Arbor on October 14<sup>th</sup>. She reminded the Board of the IPRA Conference in January and the Decennial Meeting is October 26<sup>th</sup>.

#### B. Treasurer's Report

Treasurer McDonnell presented the August Financials to the Board and informed that total cash and investments as of August 31, 2023 are \$4,217,546.19. Treasurer McDonnell informed that he will have the nine month review with comparison to the budget on the next report. The Tax Agency Reports have been received from the County and Treasurer McDonnell has reviewed and will present in November.
