we were able to promote various Park District programs. Director Dahm went over where the Park District was at in the Comprehensive Master Plan process. She included multiple graphs that displayed Oak Forest demographics in 2024, as well as projected demographics in 2029. Director Dahm brought up the recent legislation that was passed on e-scooters. She informed that with the new legislation, it was important that the Park District make a decision on how they would like to proceed with whether or not they would create an ordinance to officially prohibit e-scooters in parks. She also informed that if the Park District did create an ordinance for this, we would be following suit with an ordinance that the City of Oak Forest previously created.
